As you know, we are delighted to be taking part in the LifeSavers programme, helping our pupils learn about money and how to manage it wisely. As part of the LifeSavers Programme we have partnered with a local credit union, **Central Liverpool Credit Union**, to provide our school savings club for pupils.

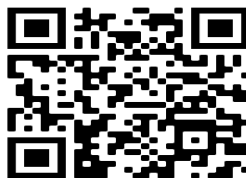
We are re-opening registration for pupils and your child has expressed an interest in joining. **To register your child, you will need to complete the attached form and return it to your child's class teacher by Friday 11th November or you can complete the form online (see web address or QR code below).** This will give us the opportunity to have your child's account ready hopefully before Christmas holidays. Your child will receive a Lifesavers passbook and wallet when they join.

The savings club will provide real life, hands-on money experiences for your children to help them develop into financially confident young people. They will learn about saving and setting savings targets for things they want. The emphasis will not be on the amount they save but developing a positive savings habit. All amounts saved, no matter how small, will be welcomed (with a **maximum limit of £5 per week**). As this is a savings club, the **first opportunity to make a withdrawal will be in July**. **No withdrawals can be made before this.**
